In response to the disruptions to the Competitions of the Wyndham Netball Association through 2020 and 2021, and in anticipating of further disruptions, the Association has issued the following amendments to the By-Laws that will take effect until 31 December 2022.

These amendments are not intended to be permanent or long-lasting. The continuance of these amendments beyond 31 December 2022, if deemed necessary, will be confirmed before the 2023 seasons commence.

# The following temporary amendments apply to All Competitions (Open Age and Junior).

## Clause 1.14

Where a Team has borrowed a player or multiple players for the commencement of the game or during the first quarter of the game to have a maximum of 7 (seven) players for the game, the Team may remove that borrowed player from the game and strike them from the scoresheet prior to the commencement of the second quarter of the game.

If the player has not been struck off the scoresheet by the commencement of the second quarter, they will remain a borrowed player for that Team and all borrowed player rules will apply to the Team and that player.

Such player can only be replaced by a player that is a registered player of that Team.

This applies to 1 (one) borrowed player only for that game.

Such player will not be considered to have participated in that game except where some disciplinary or complaint related action is required by the Board.

A player may play a maximum of 2 (two) games on any one day of Competition.

# Clause 1.21

The Board reserves the right to alter the format of the finals series as it deems necessary.

Where the Board determines that it is necessary to alter the format for finals from that detailed at Clause 1.21 c), all Teams and Clubs will be advised as soon as practicable and preferably before the regular season concludes.

#### Clause 1.21

Players in all Divisions except for the Women's Day Competition (see 5.5(a)) must play at least 40% of the games fixtured for their Team throughout the home and away season to be eligible to participate in that Division's final series. The percentage will be rounded down to the next positive integer

# The following temporary amendments apply to All Open Age Competitions.

### Clause 1.14

A Team may borrow a maximum of 3 (three) players from their Club or Other Clubs to ensure a Team of 7 (seven) players is available for a regular season game.

A player may play a maximum of 2 (two) games on any one day of Competition.

Other provisions of Clause 1.14 remain unchanged, as:

- All borrowed players must be VNA registered or hold a Single Game Voucher.
- Borrowed players do not qualify for finals.
- Borrowed players will not receive votes towards best and fairest awards.
- Borrowed players must be age appropriate for the Competition.
- Players cannot be borrowed in from higher Divisions of that Competition.
- A borrowed can play a maximum of 4 (four) times as a borrowed player in a team during the season.
- The scoresheet must clearly identify all borrowed players.
- A player that is not identified as a borrowed player and/or not borrowed correctly will be deemed to be an unregistered player for that game.

### The following temporary amendments apply to All Junior Competitions.

A player may play a maximum of 2 (two) games on any one day of Competition.

A player may be registered in 2 (two) separate age levels for the same Club, without being treated as a borrowed player.

Such players must be age appropriate for every Team where they are registered.
